Entrants must be 21 years or older and actively engaged in farming a minimum of 250 acres of corn, soybeans and/or cotton or 40 acres of open field vegetables or at least 10 acres of vegetables grown in protected culture. Entrants must reside in eligible counties in California, Kansas (noted above), Nebraska, North Carolina, Ohio, South Carolina or South Dakota where a minimum of 50,000 acres of corn and/or soybeans, 25,000 acres of cotton and/or 50,000 acres of vegetables are planted per year.
